INSTRUCTIONS FOR HOCKING COUNTY KENNEL LICENSES:

ORC 955.02 defines a KENNEL as an establishment that keeps, houses, and maintains adult dogs for the purpose of breeding the dogs for a fee or other consideration received through a sale, exchange, or lease and that is not a high volume breeder.

Register your dog on-line at www.doglicenses.us/OH/Hocking. Credit card payments only; \$3.70 processing fee applies. To access your pre-filled form you will need your Account ID and Password listed below.

IN PERSON OR BY MAIL

1. Complete this form. Be sure the correct kennel owner and street address appear on all applications.
2. List the breeds kept, along with the number of males and females over 3 months of age for each breed.
3. Enclose a check or money order for the correct fees payable to: Hocking County Auditor. Please do not send cash. Before February 1, licensing rate is \$75.00 for the first 5 tags and \$1.00 for each additional tag. After January 31, statutory late penalty increases the licensing rate to \$150.00 for the first 5 tags. Your application cannot be processed without the correct fees.
4. Please return this form, check or money order, and a **SELF-ADDRESSED STAMPED ENVELOPE** to Hocking County Auditor; 1 East Main St.; Logan, OH 43138. A receipt will be returned to you with your 2025 license tag(s).
